Romney Registration Form



RSA members in good standing may use this form to register their purebred Romney sheep.

How To Register Your Sheep:

Your Romney sheep may be registered with the RSA using this form or the online form found at romneysheep.net.

- 1. "Sheep ID" is the ear tag number your animal will be recorded with. We recommend this be a scrapie tag or flock ID.
- 2. "Sheep Name" is whatever you want to name your sheep's name. It is not required to name your sheep.
- "Color" is the most accurate description of the color of your sheep.
- "Birthdate" is the date of birth of the animal being registered. 4.
- 5. "Nat/Al/ET" refers to the way the animal being registered was conceived.
- 6. Birth type is the number of lambs in the litter.
 - SG = Single TW = Twin TR = Triplet
- 7. "Sire RSA #" is the sire's RSA registration number. This information can be found on the top left corner of the sire's registration paper.
- "Sire ID" is the ear tag and name of the sire of the animal being recorded.
- 9. "Dam RSA #" is the dam's RSA registration number. This information can be found on the top left corner of the dam's registration paper.
- "Dam ID" is the ear tag and name of the dam of the animal being recorded.
- 11. Put an "X" in the "Transfer?" box if the sheep is to be transferred to a new owner at the time of registration.

These are legal documents. They must be truthfully completed and signed appropriately.

A completed "Registration Work Order Form" must accompany this form.

Color Explanations:

Romney sheep come in a wide variety of colors. Below is a brief guide to what color your animal is for registration purposes.

Use (W, NCS, NCP, MS, MP) in the color column when you fill out this form.

NCS = Natural Color Solid - solid colored lambs with no variegation or white **NCP** = *Natural Color Pattern* - these lambs are born black with varying amounts of white or silvery markings on their face, legs, and saddle. If there is any white at all, even just a bit on the face or ears, use this designation.

MS = Moorit Solid - solid colored lambs with no variegation or white **MP** = *Moorit Pattern* - these lambs are born brown with varying amounts of white or silvery markings on their face, legs, and saddle. If there is any white at all, even just a bit on the face or ears, use this designation. Moorits have brown wool, hair skin, lips, skin around eyes, and tongue. The brown tips that occur on a black sheep are not moorit.

All applications for lambs sired by a ram NOT owned by the owner of the dam at the time of lambing must be accompanied by RSA's Certificate of **Breeding** as part of required documentation when registering sheep under the following circum- stances:

- a) when applicant is not the breeder of offspring being registered, or the owner of the sire per RSA's records
 - b) when bred ewes (dams) are purchased, or a ram (sire) is leased/borrowed
